

2023 LLOYD REES EMERGING ARTIST AWARDS

ENTRY TERMS & CONDITIONS

1. This award is being organised by Centrehouse Inc. (trading as Gallery Lane Cove + Creative Studios/GLC+CS), herein referred to as "the Organisation/the organisers" with the financial support of Lane Cove Council.
2. Entrants must be aged between 18 and 30 years of age and be no younger than 18 years of age nor older than 30 years of age on the 15 October 2023.
3. Entrants may submit up to two artworks for judging in the medium of painting, drawing or printmaking.
4. The winning artwork shall receive a prize of \$8,000 and will enter the permanent collection of the Lloyd Rees Emerging Artist Award (formally the Lloyd Rees Memorial Youth Art Award), owned by Lane Cove Council.
5. Dimensions must not exceed 1200 (h) x 1800mm (w) including the frame and multi-part works such as diptychs/triptychs and weigh less than 10kg.
6. All entries must be ready for hanging with suitable D-rings. Works on paper are to be adequately framed. Stretched canvas may not require additional frame but must have d-rings attached. Unframed works on paper may not be accepted.
7. Work must be the original work of the artist, not previously shown in Lane Cove Local Government Area and completed no earlier than December 2021.
8. The artist is deemed to have accepted sole responsibility for ensuring that the work submitted by the artist does not infringe any relevant copyright or intellectual property or First Nations Cultural laws.
9. Staff members, volunteers or other contractors associated with Centrehouse Inc are not permitted to enter the award.
10. Entries are deemed submitted if accompanied by the \$35.00 / \$60.00 (GST included) handling fee plus Jpeg images of the work no later than midnight Sunday 15 October 2023.
11. Finalists will be notified by close of business 26 October 2023 via social media, GLC+CS' website and email.
12. The judges' decision shall be final, and no correspondence will be entered into.
13. The organisers reserve the right to reject any work that does not meet the specified criteria outlined in points 1–14 inclusive.

ADDITIONAL TERMS & CONDITIONS FOR SELECTED WORKS

14. Entries selected for the finalist exhibition must be delivered by 5pm Friday 1st December and the exhibitor is responsible for all forward and return freight costs and insurances. Artists will be provided with artwork delivery details (including dates, time, and address) upon confirmation of acceptance to the finalist exhibition.
15. The work must be clearly labelled on the back with the artist's name, address, telephone number, title, medium and price.
16. All unsold works shall be collected from Gallery Lane Cove between Tuesday 2 January to Saturday 13 January (opening hours Tuesday-Friday 10am-4.30pm and Saturdays 10am-2:30pm)
17. Centrehouse Inc will act as the sale agent on behalf of the artist and shall retain 27.5% plus GST commission on the sale of work.
18. No work selected for inclusion in the exhibition shall be removed from the exhibition prior to the closing date.

19. Every care shall be exercised but the organisers shall be in no way responsible for any damage, loss or theft. And insurances against any such loses is the responsibility of the artist.
20. The organiser will dispose of works not collected by the end of the collection period at their own discretion.
21. Image Reproduction

a. Consent for Reproduction

By submitting your artwork for consideration in the Lloyd Rees Emerging Artist Award, you hereby grant Centrehouse Inc. (trading as Gallery Lane Cove + Creative Studios) and Lane Cove Council the non-exclusive right to reproduce images of your submitted artwork for the sole purpose of promoting the Award and Centrehouse Inc."

b. Perpetual Use

You agree that the Organisation may use the reproduced images of your artwork in perpetuity for promotional purposes. This includes, but is not limited to, the promotion of the Lloyd Rees Emerging Artist Award and Centrehouse Inc. on all digital platforms known and unknown, such as Instagram, Facebook, and the Organisation's official website.

c. Cropping and Format

The Organisation may crop and adjust the format of the images of your artwork as necessary to suit various promotional materials. No other changes or modifications to the artwork will be made without your express consent.

d. Philanthropic Alignments

You acknowledge and agree that the reproduced images of your artwork may be used by the Organisation for the purpose of seeking future sponsorship of the Lloyd Rees Emerging Artist Award or for other philanthropic alignments that support the mission and objectives of the Organisation.

e. No Compensation

You understand and agree that no fees or compensation will be payable to you, the artist, for the reproduction of your artwork's images for promotional purposes. This use is voluntary and solely for the benefit of promoting the Award and the Organisation.

f. Copyright and Ownership

You retain all copyright and ownership rights to your artwork. The Organisation is granted a limited, non-exclusive right to use images of your artwork for the specified promotional purposes only.

g. Withdrawal

You have the right to request the withdrawal of your artwork from any promotional materials at any time. The Organisation will make reasonable efforts to promptly comply with such requests.

h. Indemnity

You agree to indemnify and hold harmless the Organisation, its officers, employees, and agents from any claims, demands, or actions arising out of or in connection with the use of the images of your artwork as described in these terms and conditions.
