



Terms and Conditions Exhibit in Gallery Lane Cove + Creative Studios Public Art Sculpture Plinths

An exciting opportunity exists for artists working in 3D mediums to exhibit their work with Gallery Lane Cove + Creative Studios for only \$20 per week per plinth

Artists producing small-scale three-dimensional work are invited to apply to exhibit in Gallery Lane Cove's outdoor sculpture plinth. Located in Library Square on Longueville Road, the Sculpture Plinth offers a position of high exposure within Lane Cove's central foot traffic precinct.

The Library Square Sculpture Plinth and the Gallery plinth suits small scale sculptural works, maquettes, 3D textiles, ceramics and installation works are also welcome.

The Library Square Sculpture Plinth and Gallery plinth offer a fully enclosed display area measuring:

- Artists must be aware that the sculpture plinth is in a position that receives direct sunlight and is not 100% guaranteed to be water/condensation proof.
- Exhibition spaces are available throughout 2025 for one month exhibition slots. You will be advised by a staff member upon successful application and confirmation of install and deinstall dates will be made.

1. Artworks on display in the Library Sculpture Plinth or/and the Gallery plinth are at the artist's own risk. Gallery Lane Cove + Creative Studios take no responsibility for the care of art works whilst in the sculpture plinth which although is under lock and key, is essentially a public artwork. Any lost or damaged items are the responsibility of the artist.
2. The artist is responsible for the costs and organisation of insurance for their artworks. This includes all travel costs.
3. Installation of the work is the responsibility of the artist. A staff member will provide access to the plinth and will organise artwork signage.
4. A flat fee of 30% commission on sales applies to all works sold during the period of display. All money from the sale of the artworks will be handled through the Gallery. All works must have a 10% GST component added to the final sale price and the GST can be paid on behalf of the artist if the artist is not GST registered. Gallery Lane Cove is registered for GST and must charge 10% GST on all goods sold in the Gallery. The artist fee will be paid to the artist on receipt of a tax invoice from the artist.
5. Artworks do not have to be for sale.
6. The artist, by submitting an application, understands that the Sculpture plinth is positioned in direct sunlight and is not 100% guaranteed to be condensation/waterproof. Any damage or deterioration that occurs to the artwork while on display is at the cost and responsibility of the artist.
7. There is a hire fee of \$20 per week per plinth.
8. Gallery Lane Cove + Creative Studios reserves the right to refuse any application for use of the Gallery Lane Cove Library Square Sculpture Plinth where the staff member believes that the display of the artwork to be contrary to the public interest. Disputes may be referred to the Gallery Lane Cove + Creative Studios Committee President whose decision shall be final.
